Solution Description

Procurement, Contract and Pricing

The City of Aurora used the Marketplace.city Clearbox process to find and procure their Body Camera solution. The process evaluated over 30 companies, with the City identifying 6 best fit leaders for vendor outreach. Aurora conducted a proof of concept with the top 2 vendors to pilot product usability, features, and retention capabilities. Multiple solutions met Aurora's criteria on basic functionality, usability and experience. Axon's usability, tech specifications, pricing, new features, growing customer base, and strong support references, and preference from the Aurora end users were the major factors contributing to the selection.

Axon's solution is structured as a service over 5 years. The City of Aurora is not responsible for any changes/upgrades to the hardware, accomplishing the City's goals for both a predictable, cost effective solution while ensuring the program maintains at the forefront of technology advances. The Solution includes BWC hardware, evidence management software, and other accessories to support the BWC Program. Hardware Refreshes take place in years 3 and 5.

The final Master Services Purchase Agreement includes other public safety solutions (including dash cameras, tasers). The bundling approach allowed the city to achieve 30% cost savings over the lifetime of the contract.
